<u>Membership Report</u>: President Elect Gary Hansen reported that there were now 138 members as of this meeting. He urged those who had not yet paid for membership to see him after the meeting.

<u>Previous Minutes</u>: The February 11th, 2010 minutes of the Executive Board of the South Dakota Bandmasters Association were read by the secretary/treasurer to the membership. After some corrections president Carlson declared the minutes approved as read.

<u>Members in distress</u>: Arlen Holfer added Jimmy Joe Gillespy, deceased, to the list read from the Executive Board minutes from yesterday. President Carlson asked for a moment of silence.

<u>SDBA Scholarship Report</u>: Toby Rath reported that he had mailed information to the colleges and universities and that the applications are due the Friday before All State Band.

<u>Convention Bands Report</u>: President Carlson quizzed Bob Goheen about convention bands applications. Bob Goheen said they could get them to him by All State Band. President Carlson encouraged members to submit application recordings.

ASB Site Chair Report: Jackie Stacey reported briefly on the 2010 All State Band in Watertown. There is a new hotel in town and information will be provided in the student's music packets.

<u>Young Band Director Award</u>: President Carlson reported that he had appointed Brian LeMaster as chair for this committee. Brian will chose the other members of the committee.

<u>Articles of Incorporation</u>: The membership were given a copy of the proposed Articles of Incorporation and revised By Laws. After encouragement from president Carlson the this would be a good thing to approve. <u>Motioned</u> by Toby Rath, second by Steve Solem to approve the documents. Carried

<u>Future Conventions</u>: Dr. David Reynolds spoke to solicit ideas for the 2011 convention and beyond. He asked the membership to contact him with any ideas.

All State Jazz Band Report: Dennis McDermott reported on the 2010 All State Jazz Band in that audition CD's were due march 1st. President Carlson will work with Ken Pickering to draft a letter to be sent to each region president.

President Carlson then ask for a round of applause for Ken for all he has done for music in the state.

The meeting was recessed at 5:00 PM until Saturday.

<u>2011 Convention</u>: Dr. David Reynolds extended an invitation to SDBA to hold the 2011 convention at SDSU. <u>Motioned</u> by Steve Solem, second by Jerry Letcher to accept the invitation. Carried President Carlson then thanked the SDSU convention staff for all their hard work for a very successful 2010 convention.

<u>Conductors gifts</u>: President Carlson mentioned a request to ask that the donation of \$1.00 by each student be in the form of cash not checks making it much easier to purchase the gifts. Ken pickering said the information is included in the students packets.
